


































## Sample Policy and Agreement Documents

#### Authorization to Capture/Use PHI on Portable Devices or Removable Media

Authorization to capture/use PHI (Protected Health Information) on a portable device or removable media is granted to the user identified below based on review and evaluation of the academic and/or business need. Users must take responsibility for the security of their devices and the information contained in it. A signed copy of this authorization is to be maintained in the student user's file and can be viewed upon request.

**Note:** While accessing network data through use of a VPN does not require the use of this form, the capturing of data obtained as a result of VPN access (e.g., through cutting & pasting, data entry into another computer) requires the use of this form.

## Sample Policy and Agreement Documents - User Agreement

#### Section 2: User Agreement

This section to be completed by the authorized user

I understand that I have been granted authorization to capture, *temporarily* store, or use PHI on a personally owned or an organization issued portable device. This authorization has been granted based on a defined academic and/or business need; therefore, usage must be limited to those uses necessary to meet that academic/business need. I agree to follow the requirements and guidelines as stated in this User Agreement. I understand that all patient identifiers must be used minimally (e.g., using first initial and last name (not full name), using only birth month and day when possible, and city and zip code instead of full address).

#### At no time will I store Social Security numbers in portable device(s) or removable media.

I agree to use physical and technical safeguards for the protection of my device/media such as ensuring the device/media is securely stored when not in use and never left unattended during use or transport. I agree to use strong password protections as well as to use encryption technology, as commercially available. I will work with IS as necessary to ensure the most effective protection is in place. I will ensure the proper destruction of all PHI from my device/ media immediately after intended use, and I will not use the device/removable media beyond the approval period. If my device/media is lost or stolen, I will immediately report the loss/theft to the IS department even if I believe that I have previously deleted all PHI from it.

## Device usage guidelines for students: handbook/orientation handout (sample)

Academic Policy – Handheld Electronic Devices
[Personal Digital Assistant (PDA)/Smartphone/Handheld Computers]

#### Classroom Usage

No electronics are allowed during any exams. Students may not be able to see/hear/feel these devices during exams [devices are to be left in purses/backpacks, no devices on any person]. If faculty allow a calculator on an exam, the calculator will be provided by the school. Students with special accommodations requiring a special device must have documented approval from the dean's office.

#### II. Clinical Usage

- A. PDAs are to be used in the clinical areas, and for lab activities and classroom exercises as directed by faculty. Use of portable electronic devices in clinical is regulated by the clinical agencies, local, state, and federal regulations and laws. All students are fully responsible for following all regulations of the Health Insurance Portability and Accountability Act (HIPAA) guidelines and for following HIPAA guidelines when using their PDAs in the clinical or other settings.
- B. Personal health identifiers (PHI) must be removed from any patient data students collect on their PDAs. Additionally, students will use a password to protect access to information on their PDAs. Infection control precautions must be maintained when using PDAs in patient care areas. Students must adhere to professional



## Device usage guidelines for students: handbook/orientation handout (sample continued)

- B. Personal health identifiers (PHI) must be removed from any patient data students collect on their PDAs. Additionally, students will use a password to protect access to information on their PDAs. Infection control precautions must be maintained when using PDAs in patient care areas. Students must adhere to professional standards for all communication including maintaining confidentiality, proper conduct for communication and communicating appropriate material.
- C. PDA telephone and camera functions must be turned off during clinical and lab sessions by placing devices in "Airplane" mode [see below for instructions to place phones in "Airplane" mode]. Students are fully responsible to ensure that they adhere to all regulations at all times whether at school, at clinical, on break, or anywhere else. This includes proper management of confidential client information.
- D. With the exception of specified course required activities, sending or receiving text or other messages on the PDA during class, clinical or lab is not permitted.
- E. Using the internet for personal, non-school related functions is strictly prohibited. Inappropriate PDA use or violation of HIPAA guidelines is cause for termination from the School of Nursing.
- F. Students will sign the Medical Center electronic compliance form [Authorization to Capture/Use PHI on Portable Devices] prior to entering any clinical setting at any facility annually for all courses and quarterly for Fundamentals. This form will be placed in each student's file.

#### III. Using Airplane Mode – (iPhone)

- A. Go to "Settings"
- B. Tap "Airplane" mode ON
- C. Tap WiFi ON
- D. You will not be able to receive phone calls/text messages online. You will be able to get online clinical applications.
- F. If students need to give a number to family members for contact give the facility
